MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MEDINA HELD ON MONDAY, FEBRUARY 26, 2018 AT 7:00 P.M. IN THE TOWN OF SHELBY TOWN HALL.

Mayor Sidari called the meeting to order at 7:00 p.m. with the Pledge of Allegiance to the flag.

The Mayor recognized Alaina Wilson who presented a proposal for a dog park. The proposal included steps for development of the park, information for maintenance and utilization of the park, and a map with a proposed location. The Mayor and the Board complimented Ms. Wilson on her thorough proposal but requested different locations be considered. Code Officer Busch suggested an area near the Compost Building on North Gravel Road. This will be reviewed for discussion at the next meeting.

Mayor Sidari presented a Certificate of Achievement to retired Department of Public Works employee Morris Patterson. The Mayor and Board members congratulated Patterson on his 30 years of service to the Village.

The Mayor reported that there would be a public information meeting at Brockport Middle School with the NYS Canal Corporation on March 6, regarding the recent brush and tree trimming along the towpaths.

The Mayor also reported that Department Heads and union representatives were working with Evans Insurance Agency on an employee training program.

Mayor Sidari said that the Village would not be hiring Mountain Machine Works for RBC repair, as resolved at the February 12 meeting. DPW employees would be performing these repairs for a small fraction of the cost quoted by Mountain Machine Works.

Trustee Toale reported that he had attended a NYS DEC inspection at the Wastewater Treatment Plant. He praised WWTP Operator Steve Rodland for his efficiency operating the plant and during the inspection.

Fire Chief Lupo and Police Chief Kenward submitted their monthly reports and gave brief summaries of their department activities.

Code Officer Busch updated the Board on a few ongoing projects. He also mentioned that New York State has initiated a program for residential vacant properties and could take over the notifications to property owners for the Village.

Superintendent Perry reported that his department is continually filling potholes and has fixed several water leaks. He also said that while the contractor was repairing the damage at the compost building, further damage was found, and the insurance company would be notified.

Clerk-Treasurer Padoleski noted that petitions had been filed for the Village Party, nominating incumbents Mayor Michael Sidari and Trustees Marguerite Sherman and Tim Elliott. All nominations have been accepted by the candidates.

Attorney Brooks said that he was continuing to work on the cable agreement.

Trustee Bensley reported that May 11 was scheduled for Make an Impact Day at the Medina High School and students were looking for local projects.

Trustee Sherman noted that she had discussed the invoices for the Parade of Lights and Christmas celebration with the Tourism Committee and all issues were resolved.
