- The fee for the mobile food truck was clarified as \$25 per day for a maximum of six days per month.
- The County Planning Board will review the Mobile Food Truck and Transient Retail permits for clarification and any overlapping regulations.

- Ron Stork reported that the cost for the marker including pole, and shipping is \$1,395.
