MINUTES OF THE MEETING OF THE BOARD OF THE TRUSTEES OF THE VILLAGE OF MEDINA HELD ON MONDAY, SEPTEMBER 26, 2016 AT 7:00 P.M. IN THE TOWN OF SHELBY TOWN HALL.

The Mayor called the meeting to order at 7:00 p.m. with the Pledge of Allegiance to the flag.

Jeff Lyons from Lyons Collision was recognized in the first public comment period. He was concerned about the Board's recent decision to allow Automotive Solutions to accept tow calls in the Village, on a trial basis, the last two weeks in October. This business is located outside the Village and it is Mr. Lyons' opinion that only Village businesses should be allowed to accept tows inside the Village. The Board had concurred with this, but had been advised by Automotive Solutions at a previous meeting that Lyons Collision was agreeable to sharing the tows. Mr. Lyons had not previously spoken to the owner of Automotive Solutions regarding this. The Board agreed that a letter retracting the previous approval would be sent.

Craig Lacy from Medina Parts was recognized by the Mayor in the first public comment period. He is concerned with the recent discussions regarding the parking on Main Street, particularly on the northeast section in front of his business. It is his opinion that all business owners should park in the canal basin, allowing customers to use the spaces, and that the current two-hour parking limit should be enforced so that it is not abused.

The Mayor read a request from GCASA, requesting to hang a banner in Rotary Park from October 20 to November 1, in honor of a fallen DEA agent. The Board would like more information before granting permission.

A motion was made by Trustee Bensley and seconded by Trustee Sherman. The MBA is authorized to hold their annual Beggar's Night event on Friday, October 28, from 5:30 p.m. to 7:00 p.m.

He also reminded the Board that October was Breast Cancer Awareness month and that the Annual Open House was scheduled for Sunday, October 2 from noon to 4:00 p.m.

Attorney Brooks reminded the Board of the Public Hearing scheduled for October 24, 2016. He also referred the Board to a letter he sent noting his opinion on the expenditure of Perpetual Care Funds for the Boxwood Cemetery. He indicated he would continue his research.
