- A survey has been distributed regarding the Maple Ridge Corridor Study.
- The Tony Hawk Foundation approved a matching grant for the skate park. A minimum of \$50,000 will need to be raised by the Medina Skate Society.
- The 2017 Ford Explorer Police vehicle was totaled in an accident. There were no injuries.
