MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MEDINA HELD ON SATURDAY, AUGUST 1, 2020 AT 9:00 A.M. IN THE TOWN OF RIDGEWAY TOWN HALL.

The Mayor recognized Tom Rivers, the Editor of the Orleans Hub, who presented Mary Woodruff with the "Outstanding Citizen of 2019" award for her work organizing the Hometown Heroes Banner Program. This program has grown significantly over the past two years and continues to be a popular project in the Village. Mary gave a speech accepting the award and attendees at the meeting gave her a round of applause for this well-deserved award.

Mary Woodruff then gave a presentation on the status of the Hometown Heroes Banner Program. She has several ideas to enhance the program including a website to highlight each banner and possibly the addition of an American flag to hang with each banner. She requested an addition to the number of banners allowed for display.

A motion was made by Trustee Elliott and seconded by Trustee Bensley. The limit on the number of Hometown Heroes banners to be hung each year is increased to 150.

The Mayor recognized Alex Feig of the Medina Skate Society. He requested that the skate park be named after Luke Nelson, a deceased skateboarder in whose memory donations for the park were started several years ago.

A motion was made by Trustee Bensley and seconded by Trustee Elliott. The skateboarding park located in Butts Park on South Main Street is officially named the Luke Nelson Memorial Skate Park, and further, a plaque is authorized to be displayed.

The Mayor distributed the Planning Board's proposal regarding the establishment of a Public Art Committee. This is in response to the recent requests for public murals in the Historic Preservation District and other areas. Trustee Bensley said that a 60-day moratorium on murals would allow the Planning Board time to address this. Trustee Sherman said that the Planning Board needs to find common ground between allowing the murals and preserving the historic district.

A motion was made by Trustee Bensley and seconded by Trustee Sherman. A public hearing is scheduled for Monday, August 24, 2020 at 7:05 p.m. regarding a local law to provide for a 60-day moratorium on public art until a review of the existing regulations and the enactment of a public art committee to review public art in the historic district.
