MINUTES OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MEDINA HELD ON MONDAY JUNE 27, 2022, AT 7:00 P.M. IN THE SENIOR CITIZENS CENTER.

Mayor Sidari called the meeting to order at 7:00 p.m. with the Pledge of

Allegiance to the flag.

Mayor Sidari opened the first public comment period.

Tom Rivers presented the Village Board with a Medina Doors framed poster which he created featuring pictures of 22 doors in Medina. Many are prominent structures within the community. Mr. Rivers said he was presenting this to the Village Board, in honor of the Deputy Mayor, Owen Toale. Trustee Toale had hired him twenty-six years ago as a journalist at the Journal Register. The Board thanked Mr. Rivers and said they planned on hanging it in the Village Clerk's Office.

Mayor Sidari said that the Board is allowed to re-apply for a CDBG grant for a water study.

A motion was made by Trustee Toale, seconded by Trustee Elliott. A public hearing is scheduled for July 11, 2022, at 7:00 p.m. to discuss community development needs, and to discuss the possible submission of one or more Community Development Block Grant applications for the 2022 program year.

The location the Medina Area Partnership is requesting for it to be displayed is on Mill Street, behind where the Hemp House is located.

A motion was made by Trustee Marciano, seconded by Trustee Toale. The Medina Area Partnership's location request to place an interactive board on Mill Street behind Hemp House is approved.

Mayor Sidari said that BMP requested that a temporary sign be allowed on their property. The sign assists the company in obtaining new employees. Zoning law does not allow for temporary signs and BMP has been sent violation notices.

A motion was made by Trustee Elliott, seconded by Trustee Marciano. To allow BMP temporary sign usage for a three-month period while the Village attorney reviews the Zoning regulations. The sign is limited to thirty square feet, double sided.

Fire Chief Jackson said has been receiving excellent reviews from the Fire Academy on all four recruits. He said Firefighter Miller was doing well in paramedic school. He thanked Trustee Marciano for spending the morning of June 20th with his department.

Police Kenward said his department had assisted the Albion Police Department will the Strawberry Festival 5K/8K run and the parade. He said his department had completed their yearly in-service firearms training. He said the yearly bike rodeo took place at Oak Orchard School on June 21. He said bike patrol has begun.

Clerk-Treasurer Burgess said that the NYCOM fall training school was scheduled from September 12 through September 16, 2022, and that she would like Board approval to sign up herself and Deputy Clerk-Treasurer Herbert to attend on September 12th, returning on September 15th.
