# Village of Medina Planning Board Meeting Minutes October 4, 2022

#### **Old Business**

<u>Special Use Permit-300 Ohio Street-</u> Catering kitchen does not need a separate special use permit. The kitchen is only for hire on occasions for offsite consumption. No action needs to be taken by the Planning Board.

#### **New Business**

<u>Sign Application</u>- <u>339 North Main Street</u>- Patriot Supply- Taking over where the Vape shop & Mandeo's Candy shop were. Using the same sign as Mandeo's candy shop, just putting Patriot Supply and logo on. A motion was made by Kathy Blackburn and seconded by Chris Goyette to approve the sign. All ayes. Motion carried.

<u>Sign Application</u>- <u>123 E Center Street</u>- Tom's Used Guns & More- Front window currently has a black transparency covering the window. The store name will be in white vinyl lettering covering 4' 10" of window. A motion to accept the sign was made by Chris Goyette and seconded by Mary Lewis. All ayes. Motion carried.

<u>Sign Application</u>- <u>345 Main Street</u>- Canal Village Farmers Market- The farmers market will be moving to the building from November-May. One sign on the door and one sign on each of the four windows. Kathy Blackburn made a motion to accept seconded by Chris Goyette. All ayes. Motion carried.

<u>Sign Application- 422 Main Street</u>-Goddess Muse- The sign that is currently there is coming down. There will be one sign on each window. 24" x 35". Kathy Blackburn made a motion to accept, seconded by Richard Moss. All ayes. Motion carried.

<u>Certificate of Appropriateness - 422 Main Street</u>- Goddess Muse- Proposed to paint the front façade a lavender. The lavender color does not fit in historic district. The Planning Board suggested painting the façade a cream color. Once the color is picked

it must get approval from Dan Gardner, Code Enforcement Officer. A motion was made by Mary Lewis seconded by Chris Goyette. All ayes. Motion carried.
