

MINUTES OF THE WORKSHOP OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MEDINA HELD ON MONDAY APRIL 10, 2023, AT 7:00 P.M. IN THE SENIOR CITIZENS CENTER.

Mayor Sidari called the meeting to order at 7:00 p.m.

The cost of providing ambulance services for public functions was discussed. The current rate is \$300.00 for the first four hours. \$75.00 is charged for each additional hour after the first four hours. The matter was tabled until the business meeting which will be held on April 24, 2023.

Mayor Sidari said that Rollin Hellner is proposing an amendment to the Central Business District Overlay to include 525 West Avenue, parcel number 79.12-2-48. It is the recommendation of the Planning Board for the Village Board to hold a public hearing to review and approve this amendment.

A motion was made by Trustee Elliott and seconded by Trustee Baker. A public hearing is scheduled for April 24, 2023, at 7:05 p.m. to amend the Central Business District Overlay to include 525 West Avenue, parcel number 79.12-2-48.

Mayor Sidari opened the Public Hearing at 7:05 p.m. on the proposed 2023-24 Budget. Mayor Sidari stated that since the budget review was in the infancy stage, the tentative figures are as follows:
