

MINUTES OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MEDINA HELD ON JANUARY 13, 2025, AT 6:00 P.M. IN THE RIDGEWAY TOWN HALL.

Mayor Sherman called the meeting to order at 6:00 p.m.

Mayor Sherman introduced Mr. Rollin Hellner. Mr. Hellner said he would like to sponsor the second Cruisin' in Medina for 2025 with the first car show to be held on Friday May 30, 2025, and ending with the Super Cruise on Main Street on August 27, 2025, with a rain date of September 3, 2025. He said they would like to utilize the Senior Citizen parking lot with the cruises held on Fridays between 5:30 p.m. and 8:00 p.m. He said they would be looking to have a few bands set up throughout the summer, including Highway 31. The matter was tabled until the business meeting.

Mayor Sherman said the position of automatic mechanic had been posted and the Superintendent of Public Works advertised the position. Mayor Sherman said she and Trustee Prawel had sat in on the interview and Superintendent Watts was recommending hiring Dan O'Connor to the position of Automotive Mechanic.

A motion was made by Trustee Prawel and seconded by Trustee Marciano. Daniel O'Connor is appointed to the position of Automotive Mechanic with a start date of February 3, 2025, with a starting salary per the CSEA contract with a seventy-eight-week probation.

Mayor Sherman said the Village had received a grant to install EV Charging Stations. She said this grant would work in conjunction with the New York Forward Grant and these two projects would be working together. She said she, the engineer, and the Department of State discussed the two grants and that the best place would be for these to be placed in the canal basin. She said EB Squared submitted an invoice for their work on the grant in the amount of \$3,750.00 and that this amount would be reimbursed to the Village when the grant funds were received.

A motion was made by Trustee Marciano and seconded by Trustee Prawel. The EB Squared invoice in the amount of \$3,750.00 will be paid out of the contingency account for grant work related to the EV Charging Station.
